

<p><b>Preporuke privrednim subjektima povodom otpočinjanja poslovne delatnosti i primene preventivnih zaštitnih mera</b></p>	<p><b>Recommendations for business entities regarding the commencement of business activities and implementation of preventive protective measures</b></p>
<p>Krizni štab za suzbijanje zarazne bolesti COVID - 19 doneo je Zaključak kojim se preporučuje svim privrednim subjektima, a naročito privrednim subjektima koji obavljaju proizvodnu delatnost, da rade, odnosno da nastave rad punim kapacitetom, uz poštovanje preventivnih mera koje se odnose na sprečavanje širenja zarazne bolesti COVID-19, kojima se osigurava bezbednost zaposlenih i korisnika usluga.</p>	<p>The COVID-19 Crisis Staff for Combating Infectious Disease adopted the Conclusion by which it is recommended that all business entities, and in particular business entities performing production activities, operate, i.e. continue to operate at full capacity, with due regard for preventive measures related to preventing the spread of the contagious disease COVID-19 which ensure the safety of employees and service users.</p>
<p>Preventivne mere podrazumevaju organizaciju posla, radnih aktivnosti i radnog prostora na taj način da se osigura bezbednost zaposlenih i korisnika usluga, kupaca, i drugih lica koja ulaze u poslovne prostorije, u kom smislu su privredni subjekti dužni da donesu poseban plan primene mera, kao sastavni deo akta o proceni rizika koji se donosi u skladu sa zakonom i propisima iz oblasti bezbednosti i zdravlja na radu.</p>	<p>Preventive measures imply the organization of work, work activities and workplaces in such a way as to ensure the safety of employees and users of services, customers and other persons entering the business premises, in which sense business entities are obliged to adopt a special plan for implementation of measures, as an integral part of the risk assessment act, which is adopted in accordance with the law and regulations in the field of health and safety at work.</p>
<p>U preventivne mere, od kojih su neke već pominjane, spadaju:</p>	<p>Preventive measures, some of which have already been mentioned, include:</p>
<ul style="list-style-type: none"><li>• fizički razmak među zaposlenima (tzv. fizička distanca), odnosno organizacija radnih aktivnosti i radnog prostora na način da se izbegne direktan kontakt između lica kada god to priroda posla dozvoljava;</li><li>• obavezna dezinfekcija prostorija, podova, mobilijara, mašina, alata i uređaja za rad posle pružene usluge svakom pojedinačnom korisniku, kao i obavezno postavljanje dezo barijera (dezinfekcionim</li></ul>	<ul style="list-style-type: none"><li>• physical distance among employees (the so-called physical distance), i.e. organization of work activities and workplaces in such a way as to avoid direct contact between persons whenever the nature of work permits;</li><li>• mandatory disinfection of premises, floors, equipment, machines, tools and devices for work after the service provided to each individual user, as well as the mandatory installation of disinfection</li></ul>

sredstvom – hlornim preparatima, preparatima na bazi alkohola sa minimalno 70% alkohola ili drugim dezinfekcionim sredstvom);

- obavezna zamena korišćenje papirne, plastične ili platnene galanterije;
- obavezno korišćenje ličnih zaštitnih sredstava tj. maski i rukavica;
- obavezna dezinfekcija nogu i ruku svih lica koja ulaze u poslovni prostor;
- često provetravanje svih prostorija;
- redovna dezinfekcija svih zajedničkih i higijenskih prostorija;
- u slučaju sumnje da neko lice ima simptome zarazne bolesti COVID-19, (povišena temperatura i jedan od znakova i simptoma – kašalj, kratkoća daha i otežano disanje) odgovorno lice privrednog subjekta dužno je da, bez odlaganja, udalji to lice iz radnih prostorija, sa preporukom da se odmah javi nadležnom domu zdravlja – COVID ambulanti; kao i
- sve druge mere koje se mogu sprovesti, a da se ne remeti proces rada, odn. proizvodnje, uz obezbeđivanje bezbednosti svih lica.

barriers (disinfectant – chlorine products, alcohol-based products with a minimum of 70% alcohol content or other disinfectant);

- mandatory replacement of used paperware, plasticware or linen ware;
- mandatory use of personal protective equipment i.e. masks and gloves;
- mandatory disinfection of the feet and hands of all persons entering the premises;
- frequent ventilation of all premises;
- regular disinfection of all common and hygienic premises;
- in case of suspicion that a person has symptoms of the infectious disease COVID-19, (elevated temperature and one of the signs and symptoms – coughing, shortness of breath and difficulty breathing) the responsible person of the business entity is obliged to remove that person from the premises without delay, with a recommendation to report immediately to the competent health center – COVID policlinic; as well as
- all other measures which can be carried out without disrupting the work process, i.e. production, while ensuring the safety of all persons.
